This exhibit provides an incredible opportunity to showcase your work in a professional, public setting. The courthouse, known for hosting quarterly shows for over 15 years, will display 60 pieces across three floors, featuring artists from Charles County.

Submission Guidelines:

- **Submission Fee:** None
- **Submission Deadline:** **October 18, 2024**
- **Eligibility:** Artists must reside in or attend school in Charles County, MD
- **Art Type:** Two-dimensional artwork (oil, acrylic, watercolor, pastel, pen and ink, mixed media, photography)

Submission Requirements:

- Must be original and created by the submitting artist
- Artwork must be framed or suitable for wiring to hang. The court uses wire and hooks; a curator will be available to assist with hanging and wiring if needed.
- Submit digital images (JPEGs) of up to 3 pieces via email

Required Submission Information:

- Artist's name, email address, and phone number
- Artist's biography (half-page max, in MS Word format)
- Artist's headshot (JPEG)
- Title, medium, size, and year of each artwork
- Price (if applicable)

Important Notes (Please Read Carefully!):

- **Artists are responsible** for delivering their artwork to the courthouse on the drop-off date and picking it up after the exhibit ends. The exact pick-up date will be announced closer to the end of the exhibition.
- **Sales:** The courthouse does not facilitate sales. However, a price list and the artists' contact information will be available at the Clerk's Office. If any artwork is sold, it is up to the artist to arrange the transaction.

- **Exhibit Reception:** Thursday, November 21, 2024, from 5:00 PM – 6:30 PM
- **Exhibit Duration:** Until January 2025
