



It was a wonderful experience, and we truly enjoyed engaging with the many young adults who expressed interest in applying for our Arts Scholarship. Last year, we saw a strong turnout from young women, but to our pleasant surprise, we noticed an even greater number of young men this time around, showing a keen interest in the scholarship!

Later in the evening, we had the pleasure of receiving an unexpected visit from our board member, Clarissa Stroud, who also serves as the Scholarship Chair. Clarissa expressed how impressed she was with the way we were presenting the scholarship information to the students, and she shared that we had even run out of printed copies! It was a gratifying moment, knowing our efforts were well received. In addition to the scholarship details, we made sure to inform the students about the upcoming opportunity at ArtsFest, where they can showcase their talents in their own booth to the Charles County community.

The Charles County Arts Alliance sponsors eight \$2,000 scholarships to be awarded to highly qualified and talented graduates. This is an open competition for Charles County public, private, and homeschooled seniors pursuing an arts-related major at a four-year college or university. Interested applicants must submit a detailed resume, a 300-word essay, two letters of recommendation, an official transcript, and an audition tape or portfolio, depending on their artistic discipline. We encourage all eligible students to apply through our website. The scholarship fair was a great success, and we look forward to receiving applications from these talented individuals eager to pursue a future in the arts.

CCAA Board of Directors Winter Retreat

CCAA Board of Directors Winter Retreat

On January 18, the CCAA Board of Directors gathered for their annual Winter Retreat. This retreat served as an opportunity for the Board to reflect on the past year, assess their accomplishments, identify areas for improvement, and discuss significant topics, including the Charles County Arts Survey 2024. The day began at 9:30 a.m. with casual conversations and light snacks before the official meeting was called to order at 10:00 a.m. Diane Rausch, the meeting chair, informed the Board that a vote was needed to select an acting president for the remainder of the two-year term, with six months left to serve. Diane offered to take on the role, and the vote was unanimous.

Throughout the retreat, the staff provided detailed reports on current happenings, including the grant season, the CCAA Galleries, social media updates, and preparations for ArtsFest 2025. A year-end wrap-up included discussions on membership retention and recruitment efforts, CCAA scholarships, the Charles County Arts Survey, and the Spotlight on the Arts YouTube program. The Board also reviewed future events, such as the upcoming CCAA Annual Membership Meeting, the upcoming Board elections, and potential new opportunities for the organization. The retreat was a full-day meeting that concluded at 4:00 p.m., with lunch from Panera served during the session.

In addition to reviewing reports, the Board carefully examined the data from the Charles County Arts Survey 2024. The members were divided into three groups, each tasked with analyzing one of the three data points from the survey. As they compared the new survey results to those from 2021, the Board members identified key trends and shared ideas on how to better serve the community based on the survey findings. The collaborative discussions allowed the Board to gain new insights into how the arts scene in Charles County was evolving.

By the end of the Winter Retreat, the Board felt accomplished and motivated, ready to embark on new initiatives for the year ahead. The meeting fostered a sense of excitement for the future, and the Board left with a renewed commitment to working closely with the community to continue fostering the arts in Charles County.

Charles County Arts Alliance Prepares for Maryland Arts Day 2025

“Art Transforms Lives and Strengthens Communities.”

The Charles County Arts Alliance (CCAA) is gearing up for Maryland Arts Day 2025, the state's largest annual gathering of arts advocates. Hosted by Maryland Citizens for the Arts (MCA), this critical event takes place on Thursday, February 13, at Saint John's College in Annapolis, uniting artists, educators, and community leaders to champion the arts and advocate for vital funding.

This year's Arts Day is especially significant due to proposed changes in state funding. While Governor Wes Moore's FY26 budget includes \$34 million for the Maryland State Arts Council (MSAC), the accompanying Budget Reconciliation and Financing Act (BRFA) proposes eliminating the Arts Stabilization Act, threatening the consistent investment that has supported Maryland's thriving arts ecosystem for over 30 years.

What's at Stake for Charles County

MSAC funding is crucial for organizations like the CCAA, empowering them to create impactful programming, support local artists, and foster a vibrant community. Last year, CCAA joined Southern Maryland advocates to push for full MSAC funding, the Arts and Culture Capital Grant Program, and the reallocation of \$1 million to MSAC. With a 4:1 return on investment, arts funding delivers clear economic and cultural benefits.

What to Expect at Arts Day 2025

- **Meet Legislators:** Share the importance of arts funding with Maryland lawmakers.
- **Inspiring Speakers:** Hear from leaders like Maryland Poet Laureate Lady Breon.
- **Connect and Advocate:** Join arts professionals from across the state in meaningful discussions.



CCAA ArtsFest 2025 is Coming!

ArtsFest 2025 preparations were well underway, and I had been working diligently over the past month to get everything organized. I focused on preparing the registration forms, contracts, and flyers for the event. In addition, I maintained close communication with the Town Clerk of Indian Head to ensure that all logistical details were in place for a smooth and efficient setup on the day of the event. With Early Bird registration opening on February 1, I was excited to reach out to potential vendors and begin securing their participation.

One of my main tasks was coordinating with food vendors, which is always a critical part of ArtsFest. I worked hard to bring in high-quality food vendors, hoping to secure some great choices from previous years. In 2024, Better Than Mom's Home Cooking and Kona Ice expressed their interest in returning for ArtsFest 2025, which was very exciting. I was committed to ensuring a diverse and appealing selection of food options to make the festival a success.

I also spent time planning the layout for the ArtsFest 2025 site. Using feedback from the ArtsFest 2024 survey, I reviewed the layout of the Indian Village Green vendor area to better accommodate the needs of the vendors. I developed two potential layout designs and planned to present these ideas to the Town of Indian Head for approval. I wanted to create a layout that would enhance the experience for both vendors and attendees, making sure it was both functional and enjoyable.

Once I finalize the layout proposals, I plan to reach out to the Town Clerk of Indian Head to discuss what changes could be implemented. My goal was to ensure that the venue was optimized for the success of ArtsFest 2025, while also following any guidelines set by the town. I am confident that with my attention to detail and collaborative approach, I am setting the stage for another successful ArtsFest event.


